



## Instructions and Checklist

Applications for a military service academy nomination from Congresswoman Fletcher need to be submitted by Friday, October 31, 2025, by 5:00PM. Late applications will not be accepted. After your completed application is received, you will be notified in writing and by phone of your interview date and time. We will make every effort to accommodate your schedule or any special requests. If you have any questions, please contact Congresswoman Fletcher's office at 713-353-8680.

### Required Materials

#### PART I

**Nomination Application:** Complete the entire application form below and include a recent photograph.

#### PART II

**Recommendation Letters:** Provide 3 letters of recommendation from people who know you personally. Letters should not be written by a relative.

#### PART III

**Resume:** Submit a one-page resume that includes extracurricular activities and employment history starting in 9th grade.

#### PART IV

**Essay:** Submit a one-page essay on the topic: *"What does military service mean to you personally?"*

#### PART V

**School Materials:**

- Official academic transcripts from all high schools and/or colleges attended.
- Standardized test scores (*ACT or SAT – may be included on your transcript*).
