



Instructions and Checklist

Applications for a military service academy nomination from Congresswoman Fletcher need to be submitted by Friday, October 2, 2026, by 5:00PM. Late applications will not be accepted.

Required Materials

PART I

- Application for nomination:** Complete entire application form. Be sure to sign and date.
 - Please provide a recent photograph

PART II

- Recommendation Letters:** Please provide 3 letters of recommendation from people who know you personally. Letters should not be written by any relative.

PART III

- Resume:** Submit a one-page resume that includes extracurricular activities and employment history starting in 9th grade.

PART IV

- Essay:** Submit a one-page essay on the topic: *“What does military service mean to you personally?”*

PART V

- Materials from your school**
 - Official academic transcripts from all high schools and/or colleges attended
 - Standardized test scores (*ACT or SAT – may be included on your transcript*)

Please email, mail, or bring in your completed, signed, and dated application packet to Congresswoman Fletcher’s office. All materials **MUST** be received or postmarked by Friday, October 2, 2026.
